Dear Jerry & Mandy

This letter will confirm our conversation to you today in which we informed you of the suspension of your Amway IBO contract effective immediately based on the information outlined in this letter.

Pursuant to Amway's communications of 4 May and 23 May 2007, as well as the Undertakings you signed on 30 May 2007, you are obliged to refrain from promoting any BSMs, including websites, all of which are considered unauthorised by Amway. In addition, you may not engage in any activity associated with recruitment, which is currently suspended in furtherance of a moratorium on registration of Amway IBOs.

We recently became aware that no less than two additional IBS websites are available to the public, and that they contain information about building the Amway business, as well as lead/contact forms for potential use with prospects. The websites were available at [www.int-business-systems.com/whatwedo.htm](http://www.int-business-systems.com/whatwedo.htm) and [www.jcircle.net](http://www.jcircle.net) as of 25 June 2007. We understand these to be a websites maintained on your behalf, in violation of your Undertakings to Amway and the above communications.

In view of this, your IBO contract with Amway (UK) Ltd. is hereby suspended pending the outcome of our investigation into this matter and receipt of additional information from you. Unless and until the suspension is relaxed or lifted by Amway, you will not be entitled to receive any bonuses, rewards or other awards from Amway (UK) Ltd. or to engage in any Amway-related activities (apart from Amway required training programmes).

In order to enable us to resolve this matter, and to determine whether modifications of the suspension or additional contract sanctions (including termination of your IBO contract) are appropriate, please provide the following information within 3 business days:

1. Written confirmation or denial that you / IBS are an owner or operator of this website;
2. Written confirmation of whether you knew that the websites were operating and available for access to the public;
3. Written explanation for the existence of the websites notwithstanding your Undertakings to Amway;
4. A detail of the number of "hits" this site has received since 23 May 2007;
5. A list of all persons who have entered personal contact information through the leads form / contact page of the website, since 23 May 2007;
6. Any other information that you believe is important for Amway to review in connection with this action.

In accordance with your Amway contract and the written Undertakings you have given, failure to provide the information requested in numbered paragraphs 1 to 6 in the time requested will result in additional sanctions for non-compliance, to up termination of your contract with Amway.

We thank you in advance for your co-operation.
