Further to our communications entitled "Significant change to Amway's mode of operations in UK/Republic of Ireland" dated 4 May 2007 and "Further information on announced changes" dated 10 May 2007, which confirmed that "the production, sale or promotion of BSM are not authorised and distributed by Amway: this includes websites" We further clarified that any previous authorisations with respect to any BSMs are no longer valid. The website referenced above is available for access by IBOs having an appropriate password, and contains, among other things, descriptions and promotions of Business Support Materials, together with pricing.

We note that the above named website is still accessible on the Internet as of today. As this is a violation of the above prohibitions, we hereby advise you that your business is "not in good standing" with Amway (UK) Limited and that Amway is reviewing the appropriateness of additional sanctions.

As a result of being "not in good standing with Amway", you are not eligible for any Founders Achievement Award (FAA) and Sales Incentive Plan (SIP) payments, Non-Cash Award (NCA) qualifications or other discretionary rewards and awards for the current year, all of which are hereby forfeited irrespective of reinstatement of good standing at a later date, and that you may not hold yourself out as an Amway IBO in good standing with the company.

In order for your business to be considered for reinstatement in good standing, Amway requires that you sign and return the attached undertakings, indicating that you acknowledge and agree to comply with the terms of such undertakings. You must satisfy all of the conditions and requirements in the undertakings to have "good standing" reinstated with respect to your Amway business.

Any violation of the terms of this letter or the attached undertakings shall result in immediate termination of your Amway business and IBO contract with Amway (UK) Limited.

At Amway's discretion, these conditions and your undertakings may be notified by Amway to all IBOs downline of you, determined by Amway to be working with or otherwise associated with you. If any such IBOs are found to be selling, promoting or distributing the unauthorised BSMs described in this letter, additional action may be taken against such IBOs and, to the extent that you are found to be complicit, against your Amway business.

Please acknowledge receipt of this letter and your agreement with its terms and the attached undertakings by signing and returning the attached document within 7 days. Your failure to do so will result in further action, up to and including termination of your Amway business in the United Kingdom and Republic of Ireland.
